

**ALARM BUSINESS/ALARM AGENT APPLICATION  
INFORMATION SHEET**

The following items or information are required to be submitted before any permit can be issued:

1. Complete the application form and have it notarized.
2. Attach recent color photos to the application form. There should be two (2) photos, one full face and one profile. Please take care when attaching the photos not to staple them or attach them in such a fashion that the face portion of the photo is damaged in any way.
3. Have your fingerprints taken at the Orange Beach Police Department Jail, located in the Orange Beach Justice Center. If you are an out of town applicant we will accept fingerprints taken by another police agency provided that:
  - A. They are accompanied by an affidavit stating that the person who had his/her fingerprints taken is in fact the person named in the application and whose picture is attached.
  - B. They are sent directly to us by that law enforcement agency.

**NOTE:** You may be contacted by the Department concerning your application please allow time for processing your application, it must be processed before a permit will be issued.
